### **OPERATION "RED RUM" NETS THREE**

#### **SAN MATEO COUNTY NARCOTICS TASK FORCE TAKES DOWN NORTH COUNTY INDOOR MARIJUANA GROW OPERATIONS**

#### **SEARCH WARRANTS NET QUANTITIES OF DRUGS AND MONEY**

A three month undercover investigation by authorities culminated yesterday, Thursday December 15, 2011, in the execution of five search warrants and the arrests of three suspects on a variety of drug related charges. The investigation and arrests were a result of a coordinated effort by agents from the San Mateo County Narcotics Task Force; the Daly City police department and the San Francisco police department.

As suspected, two of the five search warrant locations were active indoor marijuana grow sites. The on-scene investigation revealed that the electricity panels in both grow houses had been bypassed. The remaining locations were the residences of the arrested suspects and/or co-conspirators. Agents seized over 640 marijuana plants in various stages of growth, seven pounds of processed marijuana and \$1700 in suspected drug profits. The estimated street value of the marijuana is approximately \$250,000.

All of the conspirators associated with this investigation are members of a close-knit Asian drug trafficking organization and not associated with any known medical marijuana collectives. All evidence suggests that this operation was a strictly for profit endeavor.
